<u>Student Graduation Certificate</u> Dual authentication Service by Sri Road

Upon graduation from a Chinese university, each student will receive the following three standard documents.

- 1. Gradutation Certificate(毕业证书)
- 2. Degree Certificate (学土学位证书)
- 3. Transcript (成绩单)

What does dual authentication mean?(双认证 Shuāng Rènzhèng)

Usually, all the aforementioned documents are issued in Chinese Language. Therefore, the recipient must submit them to the **local Public Notary Office** (公证处 **Gong Zheng Chu**) for notarization, which includes translating and verifying the details in the original Graduation Certificates.

Once notarized (公证 Gong Zheng), the document bearer (person on behalf them) should submit them to the Foreign Ministry in Beijing or the relevant Foreign Ministry in the respective province, as well as to the Sri Lankan Embassy in Beijing or the relevant consulate, for further authentication. This process is known as "Dual Authentication 双认证"

Non-Criminal Record (无犯罪记录证明 Wú Fànzuì Jìlù Zhèngmíng)

Obtaining a non-criminal record for students varies. While some universities may assist students in acquiring this document, it's not mandatory for all.

If a student doesn't request it, the university might not provide it. In cases where the university doesn't issue the record, students must independently apply at their local Public Security Bureau (公 安局 Gōng'ān Jú) using a university-provided request letter.

Students residing off-campus are responsible for obtaining their own non-criminal record. They can do this by directly visiting the Public Security Bureau with the necessary documents, either independently or with university assistance.

Sri Road Dual Authentication Service (双认证 Shuāng Rènzhèng)

Sri Road provides dual authentication services for Sri Lankan students who are unable to travel to Beijing due to long distances or because they are currently outside mainland China. This service is particularly beneficial for students who face challenges in completing the authentication process for their documentation.

Category 01 : Normal Dual Authentication Service (30 working Days)

Required documents:

- Original Notary books 公证书 of the relevant original graduation certificate
- Full front page scanned copy of Passport of the applicant (Colored)
- 1 power of attorney for the Sri Lankan Embassy (Letter format will be provided)



- After inspecting the documents, an estimated bill will be issued to the applicant.
- The authentication process will begin once full payment is received by Sri Road.
- If notarized documents submitted by students are rejected by any Foreign Ministry or Sri Lankan Embassy due to not meeting their standards, the students will be informed and will need to make the necessary modifications themselves.
- Sri Road is not responsible for rejections of documents due to translation errors or document formatting issues at the Foreign Ministry or Sri Lankan Embassy. The applicant must collaborate with Sri Road to make the required changes, resubmit the documents if needed, and cover any additional costs.
- Sri Road is not liable for any damage to the documents during delivery to or from Beijing Sri Road or the students via courier service or personnel.
- The processing duration begins from the day payment is completed, not from the day of receipt of the documents.

Special Attention - Reasons for Document Rejection

- 1. The size of the original graduation certificate does not match the photocopy attached in the notary book.
- 2. The name and passport numbers mentioned in the notary book do not match the applicant's passport copy.
- 3. The graduation dates listed in the notary book do not match those on the original graduation certificates.
